During the past year TEPS members hosted five clean up events on the banks of Omaru Creek, Wai-O-Taiki Bay and around Point England.



## Spotlight On Sewage Spills - Who To Call?

Every year for the past five years, the Upper Tāmaki Estuary has been one of the worst catchments for raw sewage overflows in Auckland. Untreated, raw sewage spilled into Point England's Omaru Creek, 47 times during 2024. Pakuranga Stream and Otara Creek are worse.

Watercare is the Auckland Council organisation who take away and treat our sewage and unblock sewage pipes. We help Watercare monitor and record sewage problems by reporting sewage spills to their phone line, or on their website www.Watercare.co.nz

All sewage pipes and pump stations have Engineered Overflow Points (EOPs). These work when pipes block. They let raw, untreated sewage leave the pipes and flow into local parks, drains and streams (the 'receiving environment'). Overflow points prevent sewage flooding back into bathrooms through toilets and drains when a sewage pipe is blocked or overloaded.

Watercare respond to sewage spills by clearing pipes, installing larger pipes and pump stations with greater capacity. It requires committed teams to clear drains,

and huge investments to keep our beaches and streams sewage free. Thank you Watercare, we know it's worth it.

Never pour fat and oil into kitchen sinks and flush only toilet paper (never 'wet wipes'). This is how we help stop sewage blockages and overflows. Advocacy is also needed to stop the connection of too many toilets into our overloaded system - see <u>Network capacity in Auckland</u>.

If your stream, park or footpath smells like an unflushed toilet or toilet paper is where it shouldn't be, in a park or on a stream bank - **call Watercare (09) 442 2222 and press 1.** 

Watercare publishes an annual report on overflows, why they happened and how they were fixed. <u>https://promising-sparkle-</u>


